As an organization, NLASW is committed to advancing health and social policy through a social justice framework. The NLASW believes that health and social policy development must reflect the social determinants of health framework.

In our submission for 2020, we continue to advocate for a provincial budget that places an emphasis on enhancing health outcomes for individuals, families and communities, and reducing inequities in access to services, programs and supports. ### Mental Health

- Integration of social workers in the K-12 education system.
- Increase access to mental health services in correctional facilities.
- Continued focus on enhancing access to mental health services and supports throughout NL.

## Seniors

- Enhancements to the home support program including an increase in the number of hours seniors can access home support services and flexibility within the program to meet individual needs.
- Increase in housing options in the community for seniors with complex mental health needs.
- Heightened policy initiatives to assist seniors who are living, or at risk of living in poverty (i.e., enhanced transportation services, elimination or reduction in dispensing fees for prescriptions that are filled monthly; and enhanced dental and vision care coverage).
- Improved access to equipment such as wheelchairs and specialized equipment that will allow people to live more independently.
- Increase to the allowance seniors receive in long term care.
- Improved access to online supports and system navigation for seniors and their caregivers.

- Continued support for community-based organizations who are working with populations who experience poverty.
